



## Pattern-Plus® 5000 Warranties

### **FULL WARRANTIES**

The warranties described herein are given to the original purchaser only AND ARE SUBJECT TO THE PROCEDURES, LIMITATIONS, DISCLAIMERS AND EXCLUSIONS SET FORTH HEREIN. The warranties cover only approved product applications as recommended by Hartco® Commercial Hardwood Floors and are effective on Hartco Mainstreet products purchased after July 1, 1999.

# FULL LIFETIME STRUCTURAL INTEGRITY WARRANTY

Hartco Commercial Hardwood Floors warrants its Mainstreet products, in their original manufactured condition, to be free from defects in lamination, assembly, milling, dimension and grading. Structural Integrity means that Mainstreet products will remain free from defects in lamination, assembly, milling, dimension and grading for as long as the original purchaser owns the home or commercial flooring. Hartco additionally warrants that all its engineered hardwood flooring products, even when applied on a radiant heated concrete subfloor with a surface temperature not exceeding 75° F, will not buckle, cup or warp for as long as the original purchaser owns the home or commercial flooring, when properly installed and maintained according to Hartco installation instruction procedures and when properly maintained in accordance with such instructions and the floor care directions provided in this binder and flooring cartons. Hardwood flooring, being a natural product, will continue to expand and contract through normal heating and non-heating seasons. Properly installed hardwood floors may consequently experience some separation between boards at different times during the year. If such separations do occur, they are not covered by this warranty.

## FULL LIFETIME ADHESIVE BOND WARRANTY

Hartco Commercial Hardwood Floors also warrants its Hartco approved recommended adhesive, when properly installed with engineered hardwood flooring products, that meet all the technical specifications that Hartco Commercial Hardwood Flooring products meet, will maintain its bond for as long as the original purchaser owns the home or commercial flooring. Proper job site pre-inspection, installation and maintenance procedures must be followed. Adhesive breakdown caused by subfloor moisture damage and/or water damage, including but not limited to, broken water pipes or flooding, is not covered under this warranty.

## 25 YEAR ACRYLIC IMPREGNATED WOOD LAYER WARRANTY

Hartco Commercial Hardwood Floors warrants, to the original owner/purchaser, that the engineered, acrylic impregnated wood layer of Mainstreet Collection floors (this excludes the Permion™ top-coat) will not wear through or separate from its multi-ply, engineered construction for a full 25 years from the date of purchase. This 25 year warranty applies to applications where normal, commercial and residential traffic conditions apply.

Finish and Impregnated Wood Surface Warranties exclude any indentations, scratches or surface damages caused by lack of proper maintenance, misuse, negligence, spiked heel shoes, water, erosion, pebbles, sand, other abrasives or insufficient protection on furniture. Using manufacturer's current recommended floor care products and floor protection products will allow you to maintain your floor's endless, rich beauty. Use of floor care products other than those especially formulated for use on manufacturer's

flooring, may damage your floor and void the warranty.

Mainstreet Collection products are warranted to the original owner/purchaser that the Permion™ urethane surface wear layer will not wear through or separate from the wood floor for a full 3 years from the date of purchase when used under normal commercial traffic conditions.

## HARTCO WARRANTY PROTECTION MEANS...

If in the unlikely event any portion of your floor should fail with respect to the provisions of these warranties, Hartco, at its sole option, to the original purchaser, will repair, refinish or replace such portion, **AT NO COST TO YOU**, with the same product or another product of equal value. In the unlikely event Hartco is unable to correct the failure after a reasonable number of attempts, Hartco will refund, if requested, the purchase price for that portion of the floor that fails.

To file a claim, first contact the Hartco retailer where the original purchase was made. If the retailer is unable to satisfy the claim, contact us at: Hartco Wood Floors, 16803 Dallas Parkway, Addison, TX 75001. Attn: Claims Department. Claims must also be filed within the warranty coverage period, and information verifying date of purchase will be required. Hartco reserves the right to have a designated Hartco representative inspect the floor and remove samples for technical analysis.

- Hartco warranties are not transferable.
- No installer, retailer, distributor or agent, or employee of Hartco Wood Floors, has the authority to alter the obligations or limitations of any Hartco warranty.

#### WARRANTY DISCLAIMERS AND EXCLUSIONS

- Color variations in flooring are a natural occurrence due to species, age, character of flooring and exposure to UV light or sunlight. For these reasons, new and/or replacement flooring may not match display samples and/or existing flooring.
- Due to color variations of product and/or samples, Hartco is not responsible for the consumer matching flooring to other wood products, such as cabinets, stair railings, trim and moldings.
- Gloss reduction is not considered surface wear.
- Wood characteristics naturally occurring such as variations in grain, color, mineral streaks, and knots, are not considered defects.

#### WARRANTY EXCLUSIONS

HARTCO WARRANTIES DO NOT COVER INDENTATIONS, SCRATCHES, STAINS OR DAMAGE CAUSED BY NEGLIGENCE, FIRE, WATER, MOISTURE, EXCESSIVE HEAT OR EXCESSIVE DRYNESS, EROSION, PEBBLES, SAND, OR OTHER ABRASIVES, PETS, INSECTS, SPIKED HEEL SHOES, WEATHER CONDITIONS OR NATURAL DISASTERS, COLOR VARIATIONS, NATURALLY OCCURRING WOOD CHARACTERISTICS, FAILURE TO FOLLOW ALL THE MANUFACTURER'S WRITTEN INSTALLATION AND/OR MAINTENANCE INSTRUCTIONS, IMPROPER MAINTENANCE, WET MOPPING, INSUFFICIENT PROTECTION, MISUSE, OR IMPROPER ALTERATIONS OF THE ORIGINAL MANUFACTURED PRODUCT. NO WARRANTIES APPLY TO ANY PRODUCT OR PRODUCTS DESIGNATED AS THRIFT, ANTIQUE, TAVERN, BARGAIN OR CABIN GRADES, SECONDS, ECONOMY GRADE, OR NON-STANDARD ITEMS.
