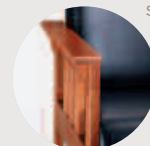

SPECIFICATIONS FOR COMMUNITY COLONY COLLECTION

MODELS: 7311D – 7312D – 7313D – 7321D – 7322D – 7323D

Wood Species: Oak or Maple

Construction: All chair parts are constructed from solid wood. The arms, back posts, side rails, and sled rails are fabricated from 1 ½" lumber. The front and back rails are made from 1 ¼" lumber. All joints are connected together with spiraled grooved, compressed hardwood dowels and assembly glue at each joint. All frames are reinforced with corner blocks which are properly fitted into the four corners of the seat frame and securely screwed and glued to the rails. For additional strength and stability, a steel screw is placed through each corner block and into the center of each adjoining leg. Interior seat construction consists of sheet webbing stretched and stapled securely to the seat frame. The seat is attached to the frame by four screws from the underside. The interior back construction consists of 3 ½" wide strips of polypropylene webbing, stretched and stapled to the back frame. The upholstered, zippered back cushion is screwed to the frame from the back side.

Finish: Each chair has an even coat of a no-wipe stain, followed by a coat of sealer. A light sanding is given and then oven dried for 30 minutes. Another coat of catalyzed sealer is applied and oven dried for another 30 minutes. Another light sanding process is performed to assure a smooth finish. Then the product is sprayed with a 45 sheen catalyzed lacquer and oven dried for an additional 30 minutes. Then there is a 30 minute cool down period before final inspection.

Upholstery: Each seat is upholstered with 3 ¼" high density polyurethane to assure consistency in thickness and comfort. The back and arms are upholstered with high density polyurethane for durability and comfort. All upholstery materials pass the California Fire Retardant Code, Class 1, Commercial Standard 191-53, Technical Bulletin #117.

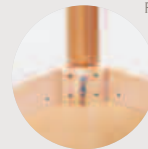

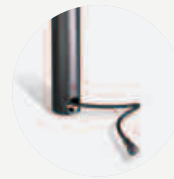

SPECIFICATIONS FOR COMMUNITY COLONY TABLE COLLECTION

- Wood:** All rails and legs are constructed from select American red oak hardwood. All lumber is thoroughly air seasoned before kiln drying to a moisture content of 6%. Then the lumber is allowed to temper before milling. Table tops are of flake board inner construction with wood grain laminated face to top. Tops are available to match manufacturer's standard finishes of customer's specified laminates.
- Construction:** Table legs are fabricated from 2" lumber. Rails are manufactured from 1" lumber and are finished to a width of 3". Vertical, mission style slats are made from 1" solid wood and are glued and pinned to the rails. Legs are fastened to the table base with special steel corner braces which are screwed securely to the rails and 2 1/2" leg bolts which are tightly secured with steel locking hex nuts. The top is fastened to the table base with wood screws. The frame is further reinforced with corner blocks which are glued and screwed.
- Edge:** Colony comes standard with flat wood edge 1 1/4" thick.
- Warranty:** Community warrants to the original purchaser that each table will be free from defects in workmanship given normal use for five years of single shift service. Tables used in restaurant applications are warranted for two years. Community will, at its option, repair any defective merchandise with the terms of the warranty. This warranty does not apply to damage resulting from accident, alteration or misuse.

WARRANTY

COMMUNITY WARRANTS TO THE ORIGINAL PURCHASER THAT EACH PIECE OF FURNITURE WILL BE FREE FROM DEFECTS IN WORKMANSHIP GIVEN NORMAL USE FOR FIVE YEARS. PRODUCTS USED IN MULTIPLE SHIFT APPLICATIONS INCLUDING BUT NOT LIMITED TO RESTAURANTS, CASINOS, NIGHTCLUBS, ETC. ARE WARRANTED FOR TWO YEARS. CASTERS ARE WARRANTED TO BE FREE FROM DEFECTS IN MATERIALS AND WORKMANSHIP FOR A PERIOD OF FIVE YEARS AND TEXTILES FOR TWO YEARS (WITH THE EXCEPTION OF COM/COL TEXTILES). COMMUNITY, AT ITS OPTION, WILL REPAIR OR REPLACE ANY DEFECTIVE FURNITURE WITHIN THE TERMS OF THE WARRANTY. THIS WARRANTY DOES NOT APPLY TO DAMAGE RESULTING FROM ACCIDENT, ALTERATION, OR MISUSE. GOODS OTHER THAN FURNITURE ARE SOLD BY COMMUNITY TO CUSTOMER WITHOUT WARRANTY.

ALL PRICES ARE LIST AND FOB FACTORY. THIS CATALOG SUPERSEDES ALL PRICES PREVIOUSLY QUOTED AND IS SUBJECT TO CHANGE. POSSESSION OF THIS PRICE LIST DOES NOT CONSTITUTE AN OFFER TO SELL. ORDERS CAN ONLY BE RECEIVED FROM AUTHORIZED COMMUNITY DEALERS.


ACCEPTANCE, MODIFICATION, ASSIGNMENT

NEITHER THIS ORDER NOR ANY INTEREST THEREIN SHALL BE ASSIGNED BY CUSTOMER EXCEPT WITH THE PRIOR WRITTEN CONSENT OF COMPANY.

PAYMENT

CUSTOMER AGREES TO PAY DEPOSIT OR DOWN PAYMENT AS REQUIRED BY COMPANY. CUSTOMER AGREES TO PAY TO COMPANY THE AMOUNT INDICATED ON THE INVOICE, 1% 15 DAYS, NET 30 DAYS FROM DATE OF INVOICE (U.S. FUNDS ONLY), FOR GOODS ORDERED. INTEREST WILL BE CHARGED AFTER 30 DAYS FROM THE DATE OF INVOICE AT THE RATE OF ONE AND A HALF PERCENT (1.5%) PER MONTH. INTERNATIONAL SALES WILL REQUIRE ADDITIONAL PAYMENT ARRANGEMENTS. NO GOODS SHALL BE SOLD ON CONSIGNMENT OR CONDITIONAL SALES BASIS. PAYMENT FOR THE GOODS DELIVERED HEREUNDER SHALL CONSTITUTE ACCEPTANCE THEREOF.

DELIVERY

THE SPECIFIC TERMS OF DELIVERY ARE AS STATED ON THE REVERSE SIDE HEREOF OR ON THE INVOICE. GOODS WHICH ARE DELIVERED IN ADVANCE OF SCHEDULE ARE DELIVERED AT THE RISK OF CUSTOMER. THE COMPANY IS NOT LIABLE FOR DELAYS OR FAILURE TO SHIP DUE TO FIRE, STRIKE, ACT OF GOD, THE PUBLIC ENEMY OR OTHER CAUSES BEYOND THE CONTROL OF THE COMPANY. SPECIAL REQUESTS INCLUDING, BUT NOT LIMITED TO, INSIDE DELIVERY, INSTALLATION, AND CALL BEFORE DELIVERY ARE NOT INCLUDED IN THE PRICE. ANY CHARGES ARISING FROM FAILURE TO MEET SHIPMENT, REROUTING WHILE IN TRANSIT, OR CARRIER STORAGE CHARGES ARE THE RESPONSIBILITY OF THE CUSTOMER. WITH RESPECT TO COMMUNITY, ALL SALES ARE F.O.B. FACTORY. COMMUNITY WILL SELECT THE CARRIER UNLESS OTHERWISE SPECIFIED ON THE ORDER. FREIGHT CHARGES FOR COMMUNITY SHIPMENTS WILL APPEAR ON COMMUNITY INVOICE OR FROM CARRIER IF SHIPMENT IS SENT FREIGHT COLLECT. CERTAIN CHAIRS FROM COMMUNITY ARE UPS SHIPPABLE AND ARE NOTED AS SUCH BY THE FOLLOWING SYMBOL: . THERE WILL BE A \$10 LIST PER CHAIR CHARGE FOR UPS PACKAGING. ANY ADDITIONAL COSTS INCURRED PACKAGING THE GOODS AS A RESULT OF REQUEST BY CUSTOMER WILL BE AT CUSTOMER'S COST. IF THE GOODS ARE NOT ACCOMPANIED BY A BILL OF LADING, COMPANY'S INVOICE SHALL BE CONCLUSIVE.

CLAIMS

ALL SHIPMENTS ARE DELIVERED TO THE CARRIER IN GOOD CONDITION AND COMPANY'S LIABILITY CEASES AFTER ACCEPTANCE BY CARRIER. IF SHIPMENT ARRIVES SHORT OR DAMAGED, THE CUSTOMER MUST FILE A CLAIM IMMEDIATELY WITH THE CARRIER. IN THE EVENT OF CONCEALED DAMAGE, NOTIFY CARRIER AND REQUEST AN IMMEDIATE INSPECTION. KEEP ALL CARTONS AND PACKING MATERIAL. FAILURE TO FILE CLAIM WITHIN 15 DAYS AFTER RECEIPT OF GOODS CONSTITUTES ACCEPTANCE AND A WAIVER OF ANY SUCH CLAIMS.

ATTORNEYS' FEES

CUSTOMER SHALL BE RESPONSIBLE FOR ALL EXPENSES AND COSTS IN CONNECTION WITH THE ENFORCEMENT BY COMPANY OF THESE TERMS AND CONDITIONS AND THE COSTS OF COLLECTION (INCLUDING THE FEES OF ANY COLLECTION AGENCIES TO WHOM THE CUSTOMER'S ACCOUNT MAY BE REFERRED), PLUS REASONABLE ATTORNEYS' FEES (WHICH ATTORNEYS' FEES SHALL NOT BE LESS THAN 25% OF THE AMOUNT DUE, UNLESS A LOWER AMOUNT IS SPECIFIED BY APPLICABLE LAW).

EXCEPT FOR THOSE OBLIGATIONS OF THE COMPANY IDENTIFIED IN THESE TERMS AND CONDITIONS, ALL RISKS RELATED TO THE QUALITY AND PERFORMANCE OF THE GOODS AND RESPONSIBILITY FOR REPAIR OR SERVICE COSTS RESTS SOLELY ON THE CUSTOMER. REMEDIES

THE REMEDIES HEREIN RESERVED SHALL BE CUMULATIVE AND ADDITIONAL TO ANY OTHER OR FURTHER REMEDIES PROVIDED IN LAW OR EQUITY. NO WAIVER OF A BREACH OF ANY PROVISION OF THESE TERMS AND CONDITIONS SHALL CONSTITUTE WAIVER OF ANY OTHER BREACH OR OF SUCH PROVISION.

INSOLVENCY

COMPANY MAY FORTHWITH CANCEL THIS ORDER IN THE EVENT OF THE HAPPENING OF ANY OF THE FOLLOWING OR ANY OTHER COMPARABLE EVENT: INSOLVENCY OF THE CUSTOMER, THE FILING OF A VOLUNTARY PETITION IN BANKRUPTCY, THE FILING OF ANY INVOLUNTARY PETITION TO HAVE CUSTOMER DECLARED BANKRUPT PROVIDED IT IS NOT VACATED WITHIN THIRTY (30) DAYS FROM THE DATE OF FILING, THE APPOINTMENT OF A RECEIVER OR TRUSTEE FOR CUSTOMER PROVIDED SUCH APPOINTMENT IS NOT VACATED WITHIN THIRTY (30) DAYS FROM THE DATE OF SUCH APPOINTMENT, OR THE EXECUTION BY CUSTOMER OF AN ASSIGNMENT FOR THE BENEFIT OF CREDITORS.

LIMITED LIABILITY

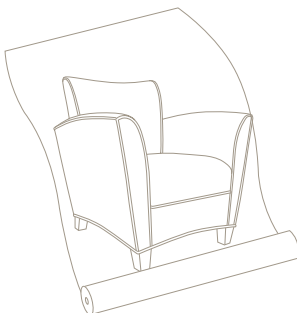

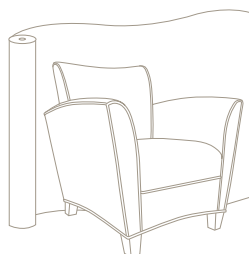
