Wood Species: Maple

Construction: All chair parts are constructed from solid wood. The side assemblies are fabricated from 1 ½" lumber. The front and back rails are made from 1 ¼" lumber. Arms and front posts are from one piece of steam bent solid hardwood. All joints are connected together with mortise and tennon and assembly glue at each joint. All frames are reinforced with corner blocks which are properly fitted into the four corners of the seat frame and securely screwed and glued to the rails. For additional strength and stability, a steel screw is placed through each corner block and into the center of each adjoining leg. Interior seat construction consists of sheet webbing stretched and stapled securely to the seat frame. The seat is attached to the frame by four screws from the underside. The interior back construction consists of 3 ½" wide strips of polypropylene webbing stretched and stapled to the back frame. The upholstered back assembly is attached to the frame from the interior of the back to the chair frame using four screws.

Finish: Each chair has an even coat of a no-wipe stain, followed by a coat of sealer. A light sanding is given and then oven dried for 30 minutes. Another coat of catalyzed sealer is applied and oven dried for another 30 minutes. Another light sanding process is performed to assure a smooth finish. Then the product is sprayed with a 45 sheen catalyzed lacquer and oven dried for an additional 30 minutes. Then there is a 30 minute cool down period before final inspection.

Hardware: Each chair is equipped standard with nickel plated tap in glides.

Upholstery: Each seat is upholstered with 2 ½" high density polyurethane to assure consistency in thickness and comfort. The back is upholstered with 1 ½" high density polyurethane for durability and comfort. All upholstery materials pass the California Fire Retardant Code, Class 1, Commercial Standard 191-53, Technical Bulletin #117.

SPECIFICATIONS FOR COMMUNITY LAUREL TABLE COLLECTION

- Materials:** All wood shall be thoroughly air and kiln dried to a moisture content not exceeding 6% at the time of assembly. All exposed wood and veneer to be well sanded and free from wormholes, pits and shakes.
- Tops:** Top sizes to be dependant upon the particular size and shape of the table ordered. Top height from floor to be 17" standard. 5-ply balanced construction wood veneer tops are available. Tops are $1\frac{3}{16}$ " thick. Constructed with butt-jointed solid lumber bands, $1\frac{1}{8}$ " thick particle board core, and a gator-ply backing sheet.
- Edge:** Beveled edge.
- Construction:** Tables are constructed using solid wood aprons and legs. Apron rails are $1\frac{13}{16}$ " and 3" wide with a $\frac{3}{16}$ " radius on the bottom edge. The legs are $1\frac{3}{4}$ " square at the top and tapered to $1\frac{5}{16}$ " at the bottom. Aprons are fastened to tops using $1\frac{1}{2}$ " wood screws. Legs attach to the apron with one $2\frac{3}{4}$ " leg bolts, metal corner bracket, lock washer and hex nut.
- Finish:** Community's multi-step step finish process includes a high quality translucent stain and clear catalyzed varnish topcoat, which enhances and protects the natural characteristic beauty of the wood. The finish combines durability and consistency with the ease of being field repairable. Veneer tops are semi-open pore.
- Warranty:** Community warrants to the original purchaser that each table will be free from defects in workmanship given normal use for five years of single shift service. Tables used in multiple shift applications including but not limited to restaurants, casinos, nightclubs, etc. are warranted for two years. Community will, at its option, repair or replace any defective furniture within the terms of the warranty. This warranty does not apply to damage resulting from accident, alteration or misuse.

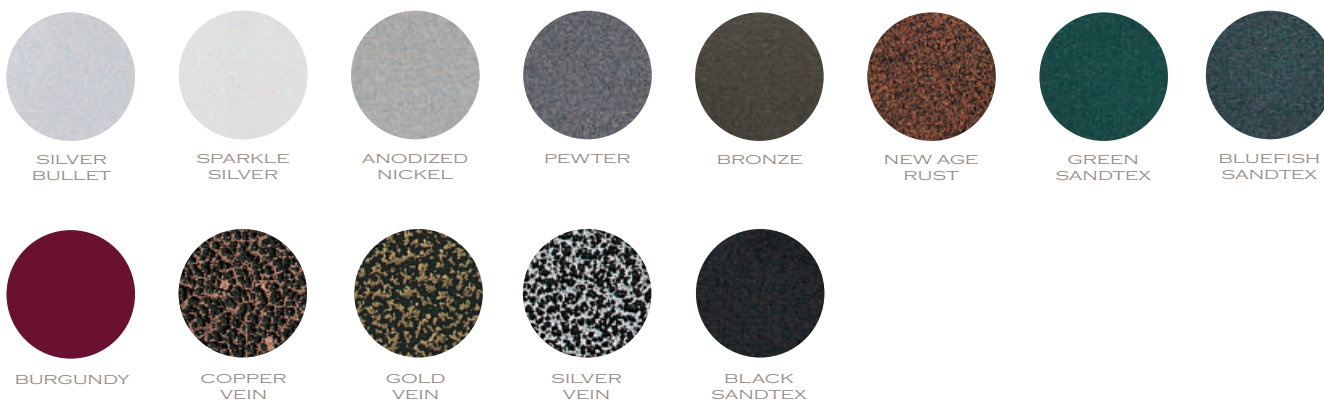

WARRANTY

COMMUNITY WARRANTS TO THE ORIGINAL PURCHASER THAT EACH PIECE OF FURNITURE WILL BE FREE FROM DEFECTS IN WORKMANSHIP GIVEN NORMAL USE FOR FIVE YEARS. PRODUCTS USED IN MULTIPLE SHIFT APPLICATIONS INCLUDING BUT NOT LIMITED TO RESTAURANTS, CASINOS, NIGHTCLUBS, ETC. ARE WARRANTED FOR TWO YEARS. CASTERS ARE WARRANTED TO BE FREE FROM DEFECTS IN MATERIALS AND WORKMANSHIP FOR A PERIOD OF FIVE YEARS AND TEXTILES FOR TWO YEARS (WITH THE EXCEPTION OF COM/COL TEXTILES). COMMUNITY, AT ITS OPTION, WILL REPAIR OR REPLACE ANY DEFECTIVE FURNITURE WITHIN THE TERMS OF THE WARRANTY. THIS WARRANTY DOES NOT APPLY TO DAMAGE RESULTING FROM ACCIDENT, ALTERATION, OR MISUSE. GOODS OTHER THAN FURNITURE ARE SOLD BY COMMUNITY TO CUSTOMER WITHOUT WARRANTY.

PRICING

ACCEPTANCE, MODIFICATION, ASSIGNMENT

PAYMENT

CUSTOMER AGREES TO PAY DEPOSIT OR DOWN PAYMENT AS REQUIRED BY COMPANY. CUSTOMER AGREES TO PAY TO COMPANY THE AMOUNT INDICATED ON THE INVOICE, 1% 15 DAYS, NET 30 DAYS FROM DATE OF INVOICE (U.S. FUNDS ONLY), FOR GOODS ORDERED. INTEREST WILL BE CHARGED AFTER 30 DAYS FROM THE DATE OF INVOICE AT THE RATE OF ONE AND A HALF PERCENT (1.5%) PER MONTH. INTERNATIONAL SALES WILL REQUIRE ADDITIONAL PAYMENT ARRANGEMENTS. NO GOODS SHALL BE SOLD ON CONSIGNMENT OR CONDITIONAL SALES BASIS. PAYMENT FOR THE GOODS DELIVERED HEREUNDER SHALL CONSTITUTE ACCEPTANCE THEREOF.

ANY ADDITIONAL COSTS INCURRED PACKAGING THE GOODS AS A RESULT OF REQUEST BY CUSTOMER WILL BE AT CUSTOMER'S COST. IF THE GOODS ARE NOT ACCOMPANIED BY A BILL OF LADING, COMPANY'S INVOICE SHALL BE CONCLUSIVE.

CLAIMS

ALL SHIPMENTS ARE DELIVERED TO THE CARRIER IN GOOD CONDITION AND COMPANY'S LIABILITY CEASES AFTER ACCEPTANCE BY CARRIER. INSOLVENCY

COMPANY MAY FORTHWITH CANCEL THIS ORDER IN THE EVENT OF THE HAPPENING OF ANY OF THE FOLLOWING OR ANY OTHER COMPARABLE EVENT: INSOLVENCY OF THE CUSTOMER, THE FILING OF A VOLUNTARY PETITION IN BANKRUPTCY, THE FILING OF ANY INVOLUNTARY PETITION TO HAVE CUSTOMER DECLARED BANKRUPT PROVIDED IT IS NOT VACATED WITHIN THIRTY (30) DAYS FROM THE DATE OF FILING, THE APPOINTMENT OF A RECEIVER OR TRUSTEE FOR CUSTOMER PROVIDED SUCH APPOINTMENT IS NOT VACATED WITHIN THIRTY (30) DAYS FROM THE DATE OF SUCH APPOINTMENT, OR THE EXECUTION BY CUSTOMER OF AN ASSIGNMENT FOR THE BENEFIT OF CREDITORS.

LIMITED LIABILITY

REASONABLE TOUCH-UP AND DELUXING IS THE DEALER'S RESPONSIBILITY. THE COMPANY WILL NOT MAKE ALLOWANCES FOR TRIP OR DELIVERY CHARGES, BUT WILL ONLY MAKE ALLOWANCE FOR ACTUAL WORK PERFORMED TO CORRECT MANUFACTURING DEFECTS. ALLOWANCES MAY BE AUTHORIZED ONLY BY A COMPANY OFFICER.

REPAIRS

INSPECTION OF GOODS UPON ARRIVAL IS MANDATORY AND ALL DEFECTS MUST BE CALLED TO THE COMPANY'S ATTENTION UPON ARRIVAL AT THE CUSTOMER'S "SHIP TO" DESTINATION. 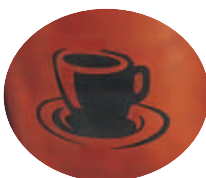

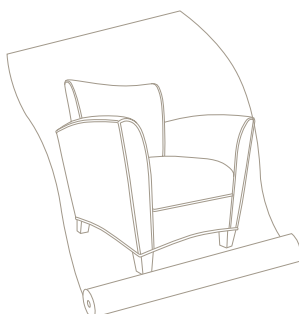

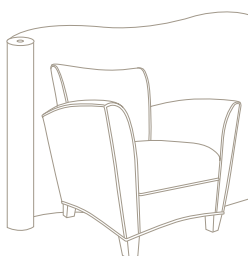
