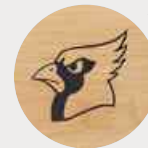

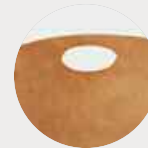

**SPECIFICATIONS FOR COMMUNITY
MELROSE COLLECTION
MODELS: 383A,B,C,D - 388A,B,C,D**

Wood Species: All parts are constructed from select oak and maple hardwood. All lumber is thoroughly air seasoned before kiln drying to a moisture content of 6%. The lumber is then allowed to temper before milling. All parts selected for steam bending are partially air seasoned before bending, then kiln dried to a moisture content of less than 6% after bending.

Construction: The seat is made from 1 ¼" lumber and is double saddled for maximum comfort and style. The seat is attached to the frame with a total of seven #12 steel screws, five through the steam bent rim and two through the front corner blocks. The back posts are made from 1 ¼" lumber and are steam bent for shape and strength. The front posts are made from 2" lumber. The two inside faces are tapered and the outside corner is shaped and rounded for style. Rails are made from 1" lumber. Both the straight front rail and the circular steam bent seat rim rail are attached to the front posts with two spiral-grooved compressed hardwood dowels and glue at each point. The rim rail is attached to the back posts by ¼" diameter bolts, washers and nuts as well as #12 steel screws at each joint. The screws are placed through the rim and into the back posts from the interior side for concealment. The stretchers are made from 1" lumber and are chucked and glued to the front posts. The steam bent circular stretcher bar is also screwed to the front posts from underneath and is attached to the back posts with #12 steel screws from inside. All back slats are steam bent and constructed from 1" lumber. The horizontal slats are attached to the back posts with mortise and tennon and glue at each joint. The frame is reinforced with front corner blocks which are glued and screwed to the front rail and steam bent seat rail rim. For added reinforcement a #12 steel screw is also placed through the middle of the blocks and into the back side of the front posts.

Finish: Each chair has an even coat of a no-wipe stain, followed by a coat of sealer. A light sanding is given and then oven dried for 30 minutes. Another coat of catalyzed sealer is applied and oven dried for another 30 minutes. Another light sanding process is performed to assure a smooth finish. Then the product is sprayed with a 45 sheen catalyzed lacquer and oven dried for an additional 30 minutes. Then there is a 30 minute cool down period before final inspection.

Hardware: Each chair is equipped standard with rubber cushion nickel plated glides.

Upholstery: Each seat consists of a 1 ½" thick high density polyurethane padding. All upholstery materials pass the California Fire Retardant Code, Class 1, Commercial Standard 191-53, and Technical Bulletin #117.

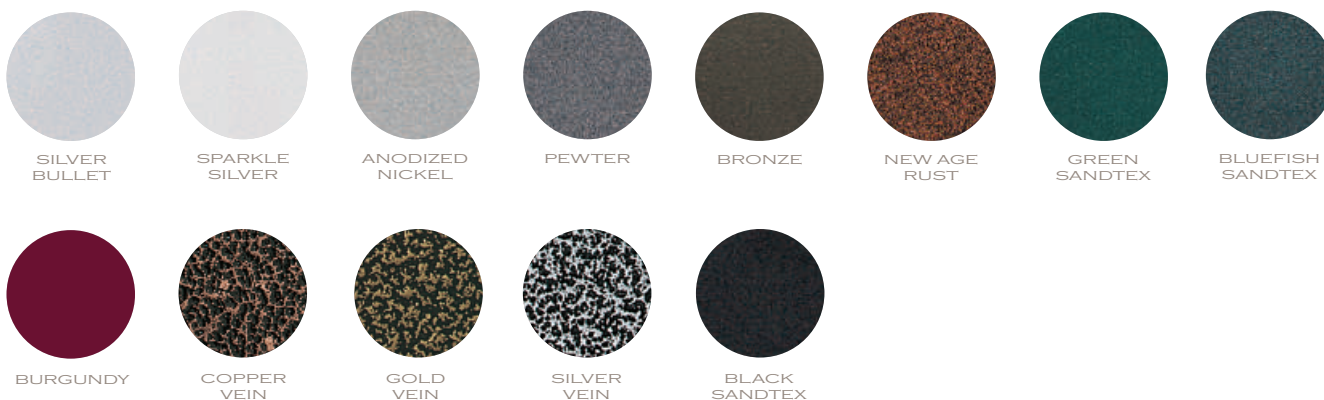

WARRANTY

COMMUNITY WARRANTS TO THE ORIGINAL PURCHASER THAT EACH PIECE OF FURNITURE WILL BE FREE FROM DEFECTS IN WORKMANSHIP GIVEN NORMAL USE FOR FIVE YEARS. PRODUCTS USED IN MULTIPLE SHIFT APPLICATIONS INCLUDING BUT NOT LIMITED TO RESTAURANTS, CASINOS, NIGHTCLUBS, ETC. ARE WARRANTED FOR TWO YEARS. CASTERS ARE WARRANTED TO BE FREE FROM DEFECTS IN MATERIALS AND WORKMANSHIP FOR A PERIOD OF FIVE YEARS AND TEXTILES FOR TWO YEARS (WITH THE EXCEPTION OF COM/COL TEXTILES). COMMUNITY, AT ITS OPTION, WILL REPAIR OR REPLACE ANY DEFECTIVE FURNITURE WITHIN THE TERMS OF THE WARRANTY. THIS WARRANTY DOES NOT APPLY TO DAMAGE RESULTING FROM ACCIDENT, ALTERATION, OR MISUSE. GOODS OTHER THAN FURNITURE ARE SOLD BY COMMUNITY TO CUSTOMER WITHOUT WARRANTY.

PRICING

ALL PRICES ARE LIST AND FOB FACTORY. THIS CATALOG SUPERSEDES ALL PRICES PREVIOUSLY QUOTED AND IS SUBJECT TO CHANGE. POSSESSION OF THIS PRICE LIST DOES NOT CONSTITUTE AN OFFER TO SELL. ORDERS CAN ONLY BE RECEIVED FROM AUTHORIZED COMMUNITY DEALERS.

ACCEPTANCE, MODIFICATION, ASSIGNMENT

BY PLACING THIS ORDER FOR FURNITURE, MATERIAL OR OTHER PRODUCTS (SOMETIMES COLLECTIVELY REFERRED TO AS "GOODS"), CUSTOMER (AS IDENTIFIED ON THE REVERSE SIDE HEREOF OR THE INVOICE) AGREES TO THESE TERMS AND CONDITIONS WHICH SHALL PREVAIL OVER INCONSISTENT PROVISIONS IN ANY OTHER FORM OR DOCUMENT OF CUSTOMER. PAYMENT

CUSTOMER AGREES TO PAY DEPOSIT OR DOWN PAYMENT AS REQUIRED BY COMPANY. CUSTOMER AGREES TO PAY TO COMPANY THE AMOUNT INDICATED ON THE INVOICE, 1% 15 DAYS, NET 30 DAYS FROM DATE OF INVOICE (U.S. FUNDS ONLY), FOR GOODS ORDERED. INTEREST WILL BE CHARGED AFTER 30 DAYS FROM THE DATE OF INVOICE AT THE RATE OF ONE AND A HALF PERCENT (1.5%) PER MONTH. INTERNATIONAL SALES WILL REQUIRE ADDITIONAL PAYMENT ARRANGEMENTS. NO GOODS SHALL BE SOLD ON CONSIGNMENT OR CONDITIONAL SALES BASIS. PAYMENT FOR THE GOODS DELIVERED HEREUNDER SHALL CONSTITUTE ACCEPTANCE THEREOF.

CERTAIN CHAIRS FROM COMMUNITY ARE UPS SHIPPABLE AND ARE NOTED AS SUCH BY THE FOLLOWING SYMBOL: . THERE WILL BE A \$10 LIST PER CHAIR CHARGE FOR UPS PACKAGING. ANY ADDITIONAL COSTS INCURRED PACKAGING THE GOODS AS A RESULT OF REQUEST BY CUSTOMER WILL BE AT CUSTOMER'S COST. IF THE GOODS ARE NOT ACCOMPANIED BY A BILL OF LADING, COMPANY'S INVOICE SHALL BE CONCLUSIVE.

CLAIMS

ALL SHIPMENTS ARE DELIVERED TO THE CARRIER IN GOOD CONDITION AND COMPANY'S LIABILITY CEASES AFTER ACCEPTANCE BY CARRIER. INSOLVENCY

COMPANY MAY FORTHWITH CANCEL THIS ORDER IN THE EVENT OF THE HAPPENING OF ANY OF THE FOLLOWING OR ANY OTHER COMPARABLE EVENT: INSOLVENCY OF THE CUSTOMER, THE FILING OF A VOLUNTARY PETITION IN BANKRUPTCY, THE FILING OF ANY INVOLUNTARY PETITION TO HAVE CUSTOMER DECLARED BANKRUPT PROVIDED IT IS NOT VACATED WITHIN THIRTY (30) DAYS FROM THE DATE OF FILING, THE APPOINTMENT OF A RECEIVER OR TRUSTEE FOR CUSTOMER PROVIDED SUCH APPOINTMENT IS NOT VACATED WITHIN THIRTY (30) DAYS FROM THE DATE OF SUCH APPOINTMENT, OR THE EXECUTION BY CUSTOMER OF AN ASSIGNMENT FOR THE BENEFIT OF CREDITORS.

LIMITED LIABILITY

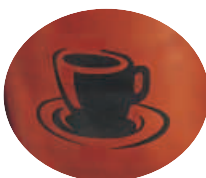

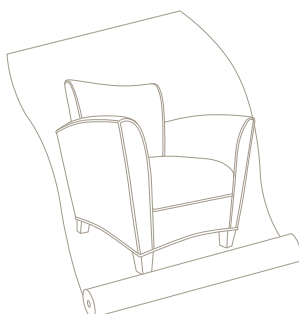

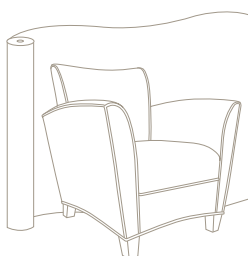
