Potential Technologies and Strategies

The intent is to reduce heat islands by designing commercial roofs to minimize the impact on microclimate and human and wildlife habitat. Reflective and vegetated roof technologies meet the intent of the credit. DensDeck may be used as a component in these high-performance roof assemblies. By the nature of its fiberglass mat construction, it avoids the contamination of absorptive materials such as traditional gypsum board or fiber board that may be incorporated into these commercial roof assemblies.
