Together with McDonough Braungart Chemistry (MBDC), one of the world's leading sustainable design firms, we're assessing all of the chemicals and materials used in our products down to a 100 parts per million-evaluating them against 19 human and environmental health criteria. As a result, we're forming a cradle-to-cradle strategy for all of our products. All major categories of materials for Disc have been assessed.

## **Life Cycle Assessment**

We are working with Steelcase to develop and implement a program of life cycle assessments for several of our major products to better understand the environmental impact of every stage of a product's life.

# **Recycling & Reuse**

We select materials that can be recycled at the end of a product's use and then design in such a way that they can be easily disassembled and separated. To simplify recycling, we minimize co-mingled components, consider the number and type of fasteners and are committed to making disassembly easy with common hand tools.

## **Other Credit Contributions**

Although not specific to this product, Brayton has other programs that can help support certain LEED credits. For example, most of our products may be blanket shipped, avoiding the need to dispose of packaging. Most of our packaging is recyclable. Also, both product longevity and end of life reuse/recycling through the Steelcase Environmental Partnership Program support N.C. – MR 3.1 & 3.2 Material Reuse, C.I. – MR 3.3 Furniture & Furnishings Reuse, E.B. – MR Prerequisite 1.1 Source Reduction & Waste Management.
