

POUL KIÆRHOLM 1929-1980

Poul Kjærholm was a trained carpenter and continued his studies at the Danish School of Arts and Crafts. He had a particular interest in different construction materials; especially steel which he considered a natural material with the same artistic fineness as other natural materials. Kjærholm was first employed at Fritz Hansen for about a year, where he designed a number of noteworthy chair prototypes. In 1955 Poul Kjærholm initiated his collaboration with manufacturer Ejvind Kold Christensen, which lasted until Poul Kjærholm's death in 1980. In 1982, Fritz Hansen took over "The Kjærholm Collection", developed from 1951 to 1967, designs, which are logical to the minute detail with an aura of exclusivity.

The lounge chair PK20 $^{\text{m}}$ is covered with leather or untreated wicker. The leather chair has a high back and headrest – and the wicker chair has a low back and is without headrest. The base is matt chromed spring steel.


UPHOLSTERY

The leather includes Classic leather; Natural leather; Elegance and White leather.


WARRANTY
