Fiber loss is defined as pile reduction that exceeds 15% in any one area, or to the point the backing is showing through to the top of the mat.

This warranty does not cover nosing or seaming. The obligation under this warranty is limited to the original user and to the replacement, repair, or pro-rated refund of said products. The labor costs of removing and/or re-installing replacement materials and associated freight costs are not part of this warranty.
