During the applicable warranty period, Indiana Furniture, as its sole obligation, will repair or replace (in Indiana Furniture’s sole discretion) any Product, part, or component covered by this warranty and sold after January 1, 2012, which fails under normal use as a result of a defect in material or workmanship. Normal use is defined as the equivalent of a single shift, 40 hour work week. Indiana Furniture will repair or replace the defective Product, part, or component with a comparable product, part or component.

- Color, grain or texture of wood, laminate and other covering materials
- Changes in wood or fabric color due to aging or exposure to light
- Damage or failure resulting from modification, alteration, misuse or abuse of a Product
- Defect or damage arising out of coverage of Product tops with glass or other foreign materials

All orders must include purchase order number, billing address, ship-to address and phone number, and any special instructions.

When ordering casegoods, give complete quantity, model number, finish and any other options. When ordering seating, give complete quantity, model number, finish, fabric and any other options.

PRICING

All prices shown are suggested retail prices FOB shipping point, freight prepaid and allowed to one continental US destination. Prices, specifications and materials are subject to change without notice. Possession and/or distribution of this price list does not in itself constitute an offer to sell. Orders can be received only from authorized Indiana Furniture dealers. Orders will be billed at prices prevailing at time of shipment, unless acknowledged prior to the effective date of the price change, in which case billing will be at the price acknowledged.

ACKNOWLEDGEMENT

If orders will be acknowledged promptly, showing how the order was entered, its approximate shipping date and other pertinent information. This acknowledgement is the final agreement between the customer and Indiana Furniture and is the exclusive statement of the terms thereof. Please examine this acknowledgement carefully and advise Indiana Furniture immediately of any discrepancies.

BUYER'S OBLIGATION: RIGHTS OF SELLER

If Indiana Furniture shall at any time doubt Buyer's financial responsibility, Indiana Furniture may decline to make shipments hereunder except upon receipt of cash payment in advance or security or other proof of responsibility satisfactory to Indiana Furniture. If buyer fails in any way to fulfill the terms and conditions set forth herein, Indiana Furniture may defer shipments until such default is corrected. Remedies provided herein shall be in addition to, and not in lieu of other remedies. Buyer agrees to abide by payment terms as listed on invoice. Buyer shall pay all reasonable costs and expenses, including attorney and collection fees, and late fees, incurred by Seller in connection with any amounts due for goods ordered.

CANCELLATIONS AND CHANGES

Due to immediate production on build to order items, all orders are considered firm and are not subject to cancellation or change without approval from Indiana Furniture. All approved changes are subject to additional charges and revised lead times.

PRODUCT DESIGN AND SPECIFICATION CHANGES

Indiana Furniture reserves the right to make changes in design and construction or discontinue products without prior notice.

REPAIR CHARGES

Indiana Furniture will only pay repair charges if Customer Service gives prior written authorization. No repair charge will be paid without advance approval at which time you will be issued a repair authorization number that will allow you to invoice Indiana Furniture for the completed work.

WAREHOUSE STORAGE CHARGES

If a shipment is held beyond 14 calendar days at your request a .067% per day (2% per month) storage charge will be assessed. The effective date will be 14 calendar days after the acknowledged ship date. Further, the prices applied to the order will be those in effect at the time of shipment.

DAMAGED MERCHANDISE

The consignee is responsible for filing claims with the carrier for damage and shortages. Claims for both obvious and concealed damage must be filed within 15 calendar days, and the damaged merchandise must not have been moved from the original receiving location. All damaged merchandise, including the cartons and packing materials, must be retained for inspection by either the carrier or by an Indiana Furniture Sales Representative. Indiana Furniture reserves the right to select the most cost effective way to repair or replace the damaged item. Once you have notified the carrier, please contact Customer Service for further assistance.

Obvious Damage/Missing Cartons - Do not refuse merchandise damaged in transit. Indiana Furniture recommends the consignee inspect all merchandise upon arrival. If a shipment is received damaged or short, note all information on carrier's copy and your copy of freight bill and delivery receipt. Notify the delivering carrier and file a claim immediately. Pending the results of your claim, either Indiana Furniture or the carrier will cover 100% of the cost to repair or replace the damaged or missing item.

Concealed Damage - If concealed damage is discovered, notify the delivering carrier at once and request an inspection. This must be done within **15 calendar days of delivery**. If the carrier will not perform the inspection, you should prepare an affidavit that you contacted them, noting the time and date, and that they failed to comply with your request. This, along with the other papers in your possession, will support the claim. Pending the results of your claim, the cost to repair or replace the item will be covered 1/3 by the carrier and 2/3 by Indiana Furniture for shipments less than a full truckload and 100% by Indiana Furniture for shipments of full truckloads.

RETURN MERCHANDISE

Merchandise will not be accepted for return without an RGA (Return Goods Authorization) issued by Indiana Furniture. We will consider issuing RGA's for the following reasons:

1. Manufacturing defect (inspected by Indiana Furniture representative)
2. Indiana Furniture order processing error
3. Shipping error
4. Mis-marked cartons
5. Duplicated shipments

If you have any questions as to whether your reason for return qualifies for consideration, please contact your Customer Service Representative. Merchandise must be returned within 60 days of the RGA issued date, or within 60 days upon receipt of replacement product to receive credit. Returns due to mis-marked cartons must also be returned in the original cartoning, with shipping labels intact, to receive credit.

All merchandise being returned must be properly packed and protected to ensure no further damage is incurred during transportation back to an Indiana Furniture facility. Upon receipt, all returned merchandise will be thoroughly inspected and the results compared to the reason for return stated on the RGA. Any discrepancies, such as additional damage, signs of usage, missing parts, etc., will result in an adjustment to the amount of credit issued.

DELIVERY AND FREIGHT CHARGES

All shipments are F.O.B. Point of Origin, Jasper, IN, freight prepaid and allowed. Ownership and responsibility of the merchandise becomes that of the buyer upon delivery to the freight company. Shipments into Alaska, Hawaii, Canada, Mexico, Puerto Rico and other exports are freight prepaid and allowed to port of exit.

Indiana Furniture reserves the right to select the most appropriate carrier and routing on all shipments. Indiana Furniture will attempt to accommodate requests for favored carriers.

Inside delivery and installation services are not included in the pricing shown. Any order requiring non-dock or residential, inside delivery must specify such on the order. Should either of these services be requested or required, all charges incurred will be charged to the "Sold To" of the order.

Orders of less than 750 pounds will be assessed a handling charge of \$75.00 Net Per Order. (This will be waived for items shipped via a small package carrier.)

BIFMA AND ANSI TESTING

Indiana Furniture is a member of the Business and Institutional Furniture Manufacturer's Association (BIFMA). Tests developed by the Business and Institutional Furniture Manufacturer's Association (BIFMA) and approved by the American National Standards Institute (ANSI) determine the strength and durability of casegoods and seating in its everyday use. Although this testing does not serve as a warranty or guarantee, Indiana Furniture products within this price list have been tested by an independent verifying body and meet or exceed applicable BIFMA and ANSI standards.

BUSINESS SIZE: Small

1a. Intended Use:

The furniture on this schedule is intended for use by Government executives (or equivalent military rank) in the Executive, Judicial Legislative Branches of the Federal Government. **Grades of construction/materials** are identified by an additional suffix (1, 2, 3, 4, 5, or 6). The grades of furniture were established to help our customers make a good purchasing decision based on their needs and budget. Grade (1) includes furniture that tends to be the most expensive on this schedule, Grade (2) furniture tends to be more moderately priced and Grades (3-6) furniture tend to be progressively more affordably priced when compared to Grades (1) and (2).

Grades of Construction/Materials:

- Grade (1) All exposed solid parts such as top rims, base rails etc. (except decorative accents, inlays and painted parts) shall be the same species as the face veneer. Top and bottom edges of drawer fronts shall be solid wood in the same species as the face veneers. Drawer sides and backs shall be solid wood.
- Grade (2) Exposed wood panel trim and rim on tops shall be the same wood species as the face veneer on the top. Some or all other exposed solid parts, such as base rails, can be an alternative wood species (such as poplar or gum) different from the face veneers. Exposed, finished engineered wood core material such as MDF is acceptable only for the edges of drawer fronts. Drawer sides shall be solid wood or veneer core plywood/laminated construction.
- Grade (3) Most or all exposed solid parts can be an alternative wood species (such as poplar or gum), different from the face veneers. Exposed, finished engineered wood core material such as MDF is acceptable only for the edges of drawer fronts. Drawer sides shall be solid wood or veneer core plywood/laminated construction.
- Grade (4) Most or all exposed solid parts can be an alternative wood species (such as poplar or gum), different from the face veneers. Exposed, finished engineered wood core material such as MDF is acceptable only for the edges of drawer fronts. Drawer sides shall be composite wood material construction such as MDF.
- Grade (5) Tops shall be high pressure laminate. Most or all exposed surfaces shall be wood veneer, high or low pressure plastic laminate or melamine overlay panel. Edges on tops, drawer fronts etc. shall be exposed, finished engineered wood core material such as MDF, self edge or decorative overlay material/process such as post formed plastic laminate or foil. Drawer sides shall be solid wood, plywood or composite wood material such as MDF with decorative overlay material.
- Grade (6) Tops shall be low pressure plastic laminate or melamine overlay panel. Most or all other exposed surfaces shall be wood veneer, low pressure plastic laminate or melamine overlay panel. Edges on tops, drawer fronts etc. shall be exposed, finished engineered wood core material such as MDF, self edge or decorative overlay material/process such as post formed plastic laminate or foil. 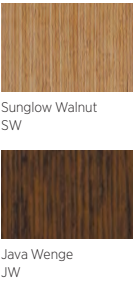

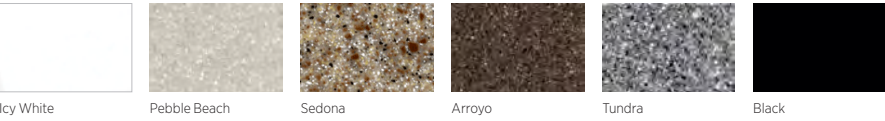

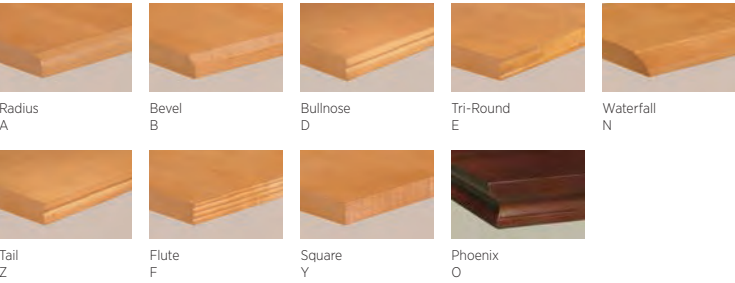

Specifications

VENEER

Exposed surfaces feature select grade sliced hardwood veneers in Cherry, Maple, American Black Walnut or composite veneers of Quartered Walnut and Quartered Wenge. Veneers are carefully selected and matched to assure proper balance and consistency.

TOPS

Work surface tops are 3-ply balanced construction and 1½" thick with a self-edge. Transaction tops 1½" thick and 5-ply balanced construction in veneer or 3-ply balanced construction in laminate. Transaction tops in Cherry, Maple and American Black Walnut have solid hardwood rims and are profiled on all sides with mitered corners. Transaction tops in Quartered Walnut and Quartered Wenge are edge-banded and have a self-edge on all sides. Grain runs left to right unless otherwise stated. Optional accent tops of ¾" glass with 2" silver standoffs are available. Transaction tops in solid surface materials are 1½" thick and available in 6 standard colors.

CONSTRUCTION

Tops and end panels are securely fastened using high quality European fastening systems to assure maximum strength. All units are equipped with heavy-duty adjustable leveling glides to ensure proper leveling and compensation for uneven floors. All units have finished backs unless noted. All pedestals have wire management access from pedestal to kneespace.

DRAWERS

All drawer fronts are standard with elegant veneer faces. Fronts are 3-ply construction ¾" thick and vertically matched in sets. Drawer interiors are constructed with wood grain vinyl wrapped sides, ½" thick. Box and file drawers have ⅛" thick hardboard bottoms. Lateral file drawers feature ¼" thick bottoms for storage applications. 5-Sided drawer construction allows for easy removal of drawer fronts.

DRAWER SUSPENSIONS

All drawers feature full extension, progressive action slides with precision steel ball bearings. Box and file drawers are tested for 100 lb capacity. Lateral files are tested for 150 lb capacity. All suspensions have a limited life-time warranty.

FILING HARDWARE

All file drawers are standard with filing systems designed to accommodate a variety of filing requirements. Modular component pedestals provide letter filing front to back and legal filing side to side. Lateral file drawers provide legal or letter filing front to back or side to side.

LOCKING

All pedestals come with standard or optional locking. Locks are black or silver to match the pull selected. Removable lock cylinders allow units to be re-keyed at a later date if required. Units are shipped randomly keyed as standard.

FINISH

All exposed surfaces are protected by Ultra-Violet finish utilizing roll-coat technology. Our durable UV finish makes surfaces less likely to be damaged by abrasions, scratches, water, alcohol, stains and common chemicals. Our UV finish magnifies the beauty of our wood finishes and reduces the darkening, aging and yellowing process of wood furniture that naturally occurs over time. Once cured by UV lighting, our UV finish does not emit irritable toxins, formaldehyde, or solvents into the air creating safe work environments within new furniture installations.



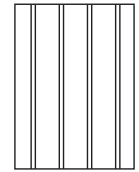

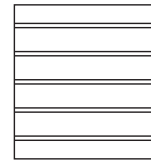

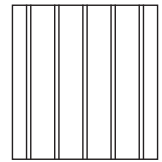

Letter Front to Back



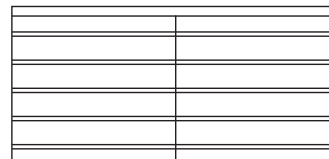
Legal Side to Side

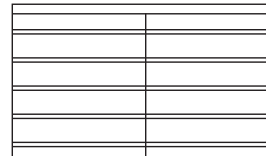
