This neutral cleaner is ideal for interior or exterior applications for removing stains and soiling.

PREPARATION

Protect people, vehicles, nearby property, plants and non masonry surfaces from product. Test all surfaces that may come in contact for compatibility. Though Rinseless Cleaner has no offensive odor, use only with good crossventilation.

Surface and Air Temperatures

Cleaning effectiveness is reduced when surface and air temperatures fall below $50^{\circ}F$ ($10^{\circ}C$). Do not apply at temperatures below $40^{\circ}F$ ($4^{\circ}C$). If freezing conditions exist prior to application, let masonry thaw.

Equipment

Apply using low-pressure spray, sponge, soft brush, broom or mop.

Storage and Handling

Keep from freezing. Store in a cool, dry place. Always seal container when not dispensing. Do not alter or mix with other chemicals. Published shelf life assumes upright storage of factory-sealed containers in a dry place. Maintain temperatures of 45–100°F (7–38°C). Do not double stack pallets. Dispose of unused product and container in accordance with local, state and federal regulations.

APPLICATION

Before use, read "Preparation" and "Safety Information."

ALWAYS TEST each type of surface for suitability and results before overall application. Test using the following application instructions.

Dilution

Dilute Rinseless Cleaner with fresh water. Always pour cold water into empty bucket first, then carefully add product.

Coverage Rates

Coverage estimates depend on surface texture and porosity. Always test for desired results.

Daily Cleaning

- 2-6 oz. concentrate : 1 gallon water
- coverage: 2700-8000 sq. ft./gal.

Severe Soilina

- 8–16 oz. concentrate : 1 gallon water
- coverage: 1000-2000 sq. ft./gal.
- water rinsing required

ALWAYS TEST

ALWAYS TEST a small area of each surface to confirm suitability and desired results before starting overall application. Test with the same equipment, recommended surface preparation and application procedures planned for general application.

Application Instructions

Daily Cleaning

- 1. Apply diluted Rinseless Cleaner.
- 2. Leave Rinseless Cleaner on the surface 1–5 minutes
- 3. Gently scrub the surface until soiling is removed.
- 4. Vacuum or mop up residual liquid and soiling.

Severe Soiling

Follow steps 1—3 for daily cleaning, then rinse thoroughly with fresh water.

Cleanup

Clean tools and equipment using fresh water.
