#### **APPROVED APPLICATIONS:**

**Tradename:** CertainTeed Ridge Vent 12" Filtered, and

CertainTeed Ridge Vent 9" Filtered

**System Type**: Mechanical attachment of static vent over asphalt shingle roof systems only.

**Slot:** Cut a minimum  $1\frac{1}{2}$ " slot along the apex of the roof by cutting  $\frac{3}{4}$ " on each side of the ridge.

The slot shall terminate approximately 6" from the rake edge.

**Installation:** Place ridge vent section centered over the void at one end of the ridge. Plugged end should

be flush with end wall of ventilated space under roof. Pre-fasten first section using roofing nails through pre-drilled nail bosses. Continue to pre-fasten remaining sections, making sure support walls are flat on roof and filter is secure between shingles and vent. Cut final

section to length.

**Ridge Shingle:** Nail cap shingles in place using roofing nails long enough to penetrate through the roof

sheathing a minimum of  $\frac{3}{16}$  of an inch. Use nail lines provided on vent.

**Net Free Area:** Refer to manufacturers published literature.

Minimum Slope: 2:12

#### **LIMITATIONS:**

1. Refer to applicable Building Codes for required ventilation.

2. This acceptance is for installations over asphalt shingle roof systems only.

3. CertainTeed Ridge Vent 12" Filtered, and CertainTeed Ridge Vent 19" Filtered Ridge Vents shall not be installed on roof mean heights greater than 33 feet.

4. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.

5. All approved products listed herein shall be labeled and shall bear the imprint or identifiable marking of the manufacturer's name or logo and following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.




