- You must make a warranty claim within the time limits and manner described in the section "How Do I Make A Warranty Claim?"

WHAT IS NOT COVERED?

USG shall not be responsible for, and this Warranty does not cover, any loss or damage resulting from:

- Storage, design, installation, or maintenance practices that are not in accordance with USG's recommendations and specifications which may be found at www.usg.com.
- Products that are not manufactured by USG or the use of products that are not compatible with each other.
- Failure to maintain the building or floor with reasonable care.
- Abuse of the flooring.
- Discoloration of the flooring, including staining due to mold, mildew, or bacterial growth.
- Outside sources of water such as where the outside grade is above the substrate, moisture caused by faulty (or lack of) vapor retarder under the concrete substrate slab per ASTM E1745, sprinklers, overflow drains not directed away from the foundations, or flooding.
- Failure to comply with the terms and conditions of this Warranty.

WHAT WILL USG DO?

USG's liability under this Warranty shall be as follows:

- If the nonconforming Product has not been installed, USG, at its election, will provide replacement Product or refund the purchase price of the nonconforming Product.
- If the nonconforming Product has been installed, USG will pay the reasonable cost of removing and replacing the nonconforming Product in the affected area and other flooring material that must be removed to replace the nonconforming Product, including reasonable labor costs.

HOW DO I MAKE A WARRANTY CLAIM?

To make a claim under this Warranty, you must give USG written notice of your claim no later than 30 days from the date the claimed problem or defect was discovered or should have been discovered on reasonable inspection. In addition, no claim may be brought more than 30 days after the end of the Warranty period regardless of the date of discovery of the alleged problem or defect. Your written claim should include a description of the problem, photographs if available, and any sales receipts, invoices, or other information indicating the date of purchase and installation.
