#### **Installation and Maintenance**

Carpet is a textile fabric, subject to stretch and/or shrinkage. An acceptable pattern match is achievable, however, a perfect pattern match cannot be guaranteed.

To achieve best results, more time should be allowed to install patterned carpet. This style has a definite pattern and must be installed according to pattern match procedures as outlined in Tarkett installation specifications, available from your Tarkett Representative.

Manufacturing tolerances on Tarkett woven carpets are: Bow - 1" per 12' width

Skew - 1" per 12' width

Edge Straightness - +/- 1/2" variation Pattern Elongation - 1" per 10' length

Width - +/- 3/4" variation

For best side match and seam appearances, it is recommended to run seams perpendicular to external light sources.

Proper maintenance is critical to the long term performance of any carpet and should be written into the specification of a project. Recommendations are available from your Tarkett Representative.
