



# ROOFING VENTILATION PRODUCTS

2023 Limited Warranty



#### What and Who are Covered and for How Long

Subject to the terms, exclusions and other limitations of this limited warranty, CertainTeed LLC ("CertainTeed") warrants from the date of installation that the Ventilation Products shown in Table 1 will be free from manufacturing defects for the specified length of time. Should CertainTeed determine that the Ventilation Product contains a manufacturing defect, CertainTeed will provide a replacement Ventilation Product at no charge. Except during the SureStart™ Protection period, as noted below, in no event will CertainTeed pay for any labor costs, including those costs required for field repair or replacement or removal of any allegedly defective product.

If CertainTeed replaces any product under this limited warranty, it may substitute products designated by CertainTeed to be of comparable quality or price range in the event the product initially installed has been discontinued or modified.

Lifetime means the limited warranty remains in effect as long as the original property owner (or the second owner, if the warranty was properly transferred during the SureStart period) owns the property where the Ventilation Product is installed.

The Ventilation Products specified in Table 1 are covered by SureStart Protection for the listed number of years from the date of installation completion provided that the Product has been installed in strict accordance with CertainTeed's written installation instructions. Under this warranty feature, CertainTeed will replace, at no charge, the Ventilation Product that CertainTeed determines to be defective during the SureStart period. CertainTeed's maximum liability under SureStart Protection will be equal to the reasonable cost to replace the defective Product, including labor.

In instances in which CertainTeed, according to the terms of this limited warranty, has agreed to pay the cost of labor required to replace a defective Intake Vent, CertainTeed will provide reimbursement only upon receipt of a copy of the contractor's invoice or other written evidence of the completion of the work which CertainTeed, at its sole discretion, deems acceptable.

## **Transferability**

This limited warranty is transferable by the original property owner to the first subsequent property owner. The warranty transfer is only effective if the first subsequent property owner provides written notice of the transfer to CertainTeed within sixty (60) days from the real estate title transfer date. Notice must be sent to CertainTeed Roofing Technical Services Department, 20 Moores Road, Malvern, PA 19355.

## Limitations

This limited warranty does not provide protection against, and CertainTeed will have no liability for, any failure, defect or damage caused by situations and events beyond normal exposure conditions, including but not limited to:

- Misuse, abuse, neglect, or improper transportation, handling or storage;
- Installation not in strict adherence to CertainTeed's written instructions;
- Impact of foreign objects, fire, flood, earthquake, lightning, hurricane, hail, tornado or other violent storms or other act of God;
- Defects in failure of or damage caused by materials used as roofing base over which the product is installed;
- · Movement, distortion, cracking or settling of walls or the foundation of the building; or
- Any other cause not a result of a manufacturing defect.

CertainTeed reserves the right to discontinue or modify any of its products, including color, and shall not be liable as a result of such discontinuation or modification, nor shall CertainTeed be liable in the event replacement products may vary in color in comparison to the original product as a result of normal weathering. If CertainTeed replaces any material under this warranty, it may substitute products designated by CertainTeed to be of comparable quality or price range in the event the product initially installed has been discontinued or modified.

#### What the Customer Must Do

If you believe that your Ventilation Product has a manufacturing defect, you must promptly notify CertainTeed and provide proof of property ownership and date of purchase and installation of the Ventilation Product. In order to properly evaluate a warranty claim, CertainTeed or its representative may be required to have access to the roof in order to perform an inspection of the Ventilation Product subject to the warranty claim, take photographs of the Ventilation Product and/or take samples of the Ventilation Product.
