This water cooler has been designed and built to provide water to the user which has not been altered by materials in the cooler waterways.

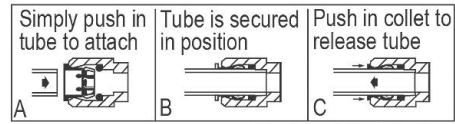
The grounding of electrical equipment such as telephone, computers, etc to water lines is a common procedure. This grounding may be in the building or occur away from the building. This grounding can cause electrical feedback into a water cooler creating an electrolysis which creates a metallic taste or causes an increase in the metal content of the water. This condition is avoidable by installing the cooler using the proper materials as shown below.

**NOTICE**

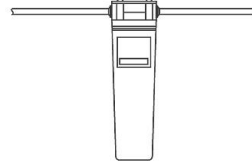
The water cooler must be connected to the water supply using a dielectric coupling. The cooler is furnished with a non-metallic strainer which meets this requirement. The drain trap which is provided by the installer should also be plastic to completely isolate the cooler from the building plumbing system.

Simultaneous operation of both bubblers on a bi-level unit may not be possible depending on water supply pressure. If simultaneous operation is desired, please ensure a minimum of 65 psi supply. Lower pressure may be possible for non-filtered and/or non-refrigerated installations.

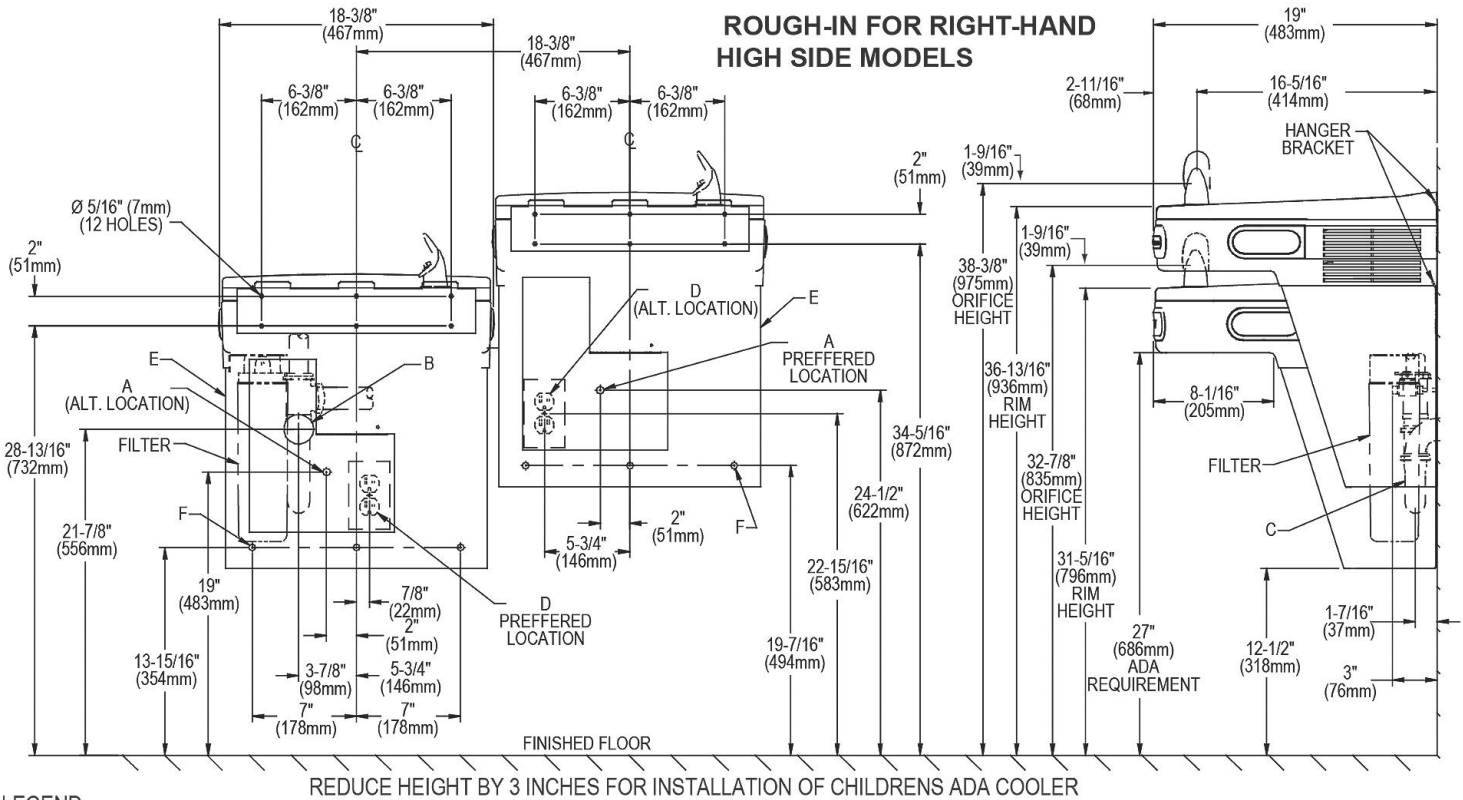


Pushing tube in before pulling it out helps to release tube

**LEGEND**

- A = Recommended water supply location. Shut off valve (not furnished) to accept 3/8" O.D. unplated copper tube. 3" (76mm) maximum out from wall.
- B = Recommended location for waste outlet 1-1/2" O.D. drain. Drain stub 2" (51mm) out from wall.
- C = 1-1/2" Trap not furnished.
- D = Electrical supply (3) wire recessed box.
- E = Insure proper ventilation by maintaining 6" (152mm) (MIN.) clearance from cabinet louvers to wall.
- F = 7/16" Bolt holes for fastening unit to wall.

NOTE: Installation instructions must use Ground Fault Circuit Interrupter (GFCI). It is highly recommended that the circuit be dedicated and the load protection be sized for 20 amps.
