## Precautions for safe handling

# Appropriate engineering controls

: Use only with adequate ventilation. Use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits. # **Environmental exposure** controls

# Skin protection Hand protection
