Shaw Industries, Inc. (“the Company”) warrants its resilient adhesives and seams sealers when used in proper fit-for-use residential and commercial applications.

The following is the Limited Warranty issued by the Company. This warranty begins when the adhesive and seam sealer are purchased and extends to the time period above. The adhesive and seam sealer must be stored under proper conditions and must be protected from freezing. The adhesive must be applied in accordance with the Company’s installation guidelines and specifications and must be applied within the shelf-life as outlined in the Technical Data Sheet (TDS). The warranty is further limited to the period of time the installation is owned and maintained by the original end-use purchaser for the original installation only. The basis of any warranty related claim is the original invoice or authorized dealer invoice.

WHAT THE WARRANTY COVERS

This Limited Commercial Warranty provides the following coverage when used within its shelf life and as outlined in the Technical Data Sheet (TDS) and installation guidelines, applicable building codes and regulations, and standard industry practices.

Manufacturing Defects - The Company warrants that the adhesive will be free of defects during the warranty period.

Adhesive Bond - The Company warrants that the adhesive will adhere/bond to the product and the floor during the duration of the warranty

as long as the Company's conditions and requirements are met.

Underbed Bond Warranty: The Company warrants that the adhesive will bond to the product and the floor and the bond will not break under rolling loads such as hospital beds for the term of the warranty for specified products. See resilient flooring product specifications for products that come with underbed warranty coverage.

It is the sole responsibility of the installer, general contractor, architect of record, or owner, as a condition of warranty coverage, to first determine the suitability and compatibility of the product for the user's intended use.

WHAT CONDITIONS APPLY

The product's must be used in accordance with the Company's published pre-installation and jobsite installation instructions. It is required that moisture testing of the substrate and substrate preparation guidelines are followed.

For moisture testing of the substrate (pH, RH% and CaCl), see product specification sheet and installation guidelines for complete instructions.

For substrate preparation, see product specification sheet and installation guidelines for complete instructions.

This warranty does not extend to or cover failure or damage resulting from the following:

Failure to follow all substrate preparation and installation guidelines; subfloors with a prior history of uncorrected moisture conditions, hydrostatic pressure problems, vapor emissions, relative humidity, or pH readings outside the specified limits; failure of claimant to have records of moisture and alkalinity testing taken prior to the installation; uneven subfloors beyond Shaw's specifications and tolerances; subfloors on which solvent adhesive removers have been used; unapproved subfloor materials; improper material selection; improper installation; complaints relative to defects in the flooring materials; damage to the adhesive or flooring caused by the introduction of outside sources of water such as where outside grade is above substrate; moisture or ground water intrusion caused by faulty or lack of a vapor retarder under the concrete substrate slab per ASTM E1745; excessive water from such cases as broken water pipes, sink overflow, leaky plumbing, flooding, weather conditions subfloor cracking, or improper maintenance; indentations or damage to the flooring from rolling bed, moving loads, high heels, spiked shoes, or chairs or other furniture not using floor protectors; improper installation of the floor covering material or defective floor covering material; installation problems associated with substrate imperfections; staining due to but not limited to mold, mildew or chemical contaminants or any other discoloration of the flooring; differences in color between flooring products and samples or photographs; or damage due to thermal heat sources.

WHAT IF YOU NEED WARRANTY SERVICE

You, the original purchaser, will contact your authorized Company dealer and/or Sales Representative for warranty or claim service. Please provide a valid proof of purchase and a detailed description of the issue, along with photographs showing the concern. Samples should be submitted for testing when available.

Dealers/Shaw Sales Representatives will file a claim via www.shawnow.com and submit the information you provided. A Shaw claims representative will thoroughly evaluate your claim.
