1.3.1. Construction: Tarkett's iQ Homogeneous flooring are composed of a 0.080" (2 mm) thick unique construction that is abrasion resistant and requires no wax. No need for polish or wax throughout the life of the product. Construction allows for dry buff for ease of maintenance.
