

Integral, tubular brass spout, 8" center-to-center. 1.5 GPM (5.7 L/min) pressure compensating, non-aerating, laminar outlet. Ceramic quarter-turn cartridge, features square, tapered stem. 1/2" NPSM supply inlets for 3/8" or 1/2" flexible riser. User-adjustable temperature control mixer. Includes temperature limiter. ECAST® construction with less than 0.25% lead content by weighted average. CALGreen compliant. This product meets ADA ANSI/ICC A117.1 requirements and is tested and certified to industry standards: Certified to NSF/ANSI 61, Section 9, and California Green Building Standards Code (CALGreen).
