

HELPFUL HINTS FOR CLEANING AND MAINTENANCE

The solid brass product you have just purchased has been designed to give you years of beauty and service. It is important to bring to your attention proper care and maintenance procedures, which will ensure its lasting beauty.

- First and foremost, it is important (as it is with any fine piece of jewelry or furniture) that the product be wiped clean and dry with a soft damp cloth after every use.
- Second, under no circumstances should an abrasive cleaner or combination cleaner/polish be used on JADO products. The abrasive nature of such products will eventually destroy the finish and void the warranty.
- In the event of stubborn blemishes shown on the finish, we recommend use of Windex window cleaner with a soft cloth, but we do not recommend it be used on an everyday basis.
- It is important to note that it is normal to expect signs of usage over time.

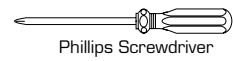

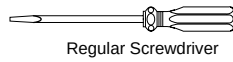

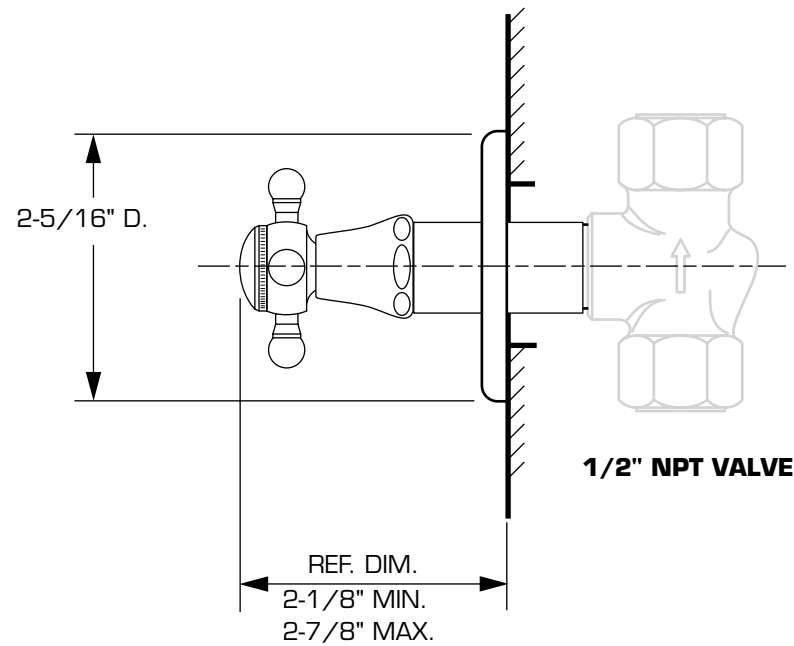

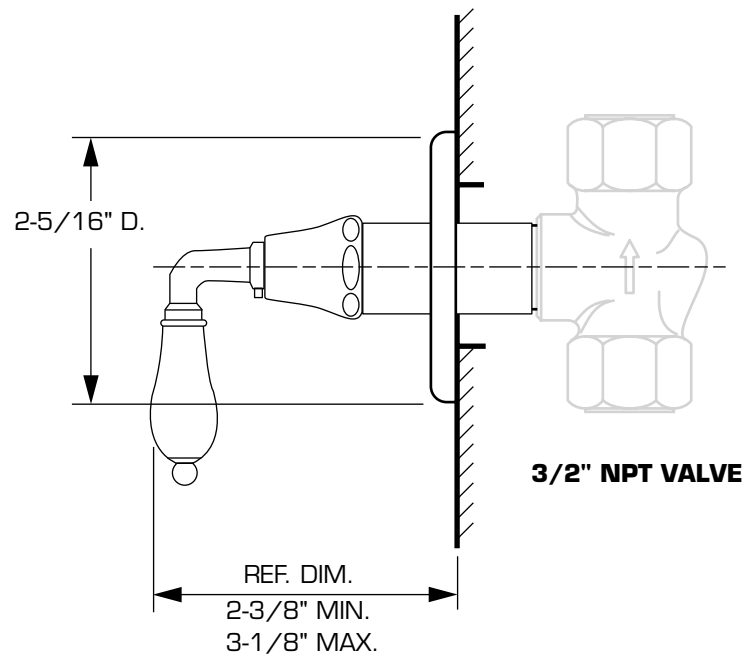

1/2" NPT VALVE

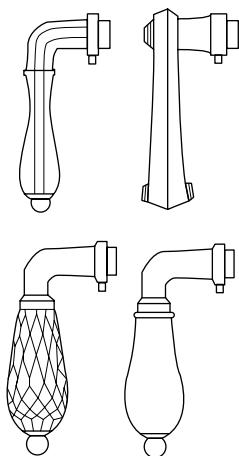
REF. DIM.

LEVER HANDLE OPTIONS



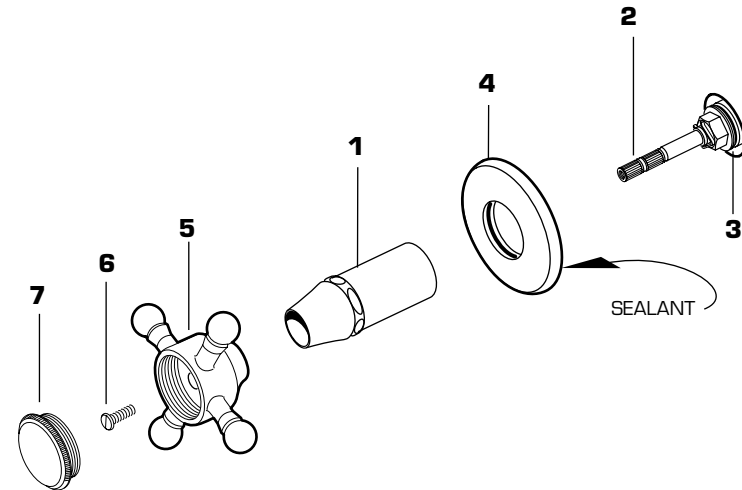

INSTALL CROSS HANDLE

CAUTION

Turn off hot and cold water supplies before beginning.

- Apply sealant to groove on back side of ESCUTCHEON (4). Slide ESCUTCHEON (4) onto BARREL SLEEVE (1).
- Install BARREL SLEEVE (1) over VALVE STEM (2) and thread onto VALVE (3) until it seats tight against the internal stop.
- Slide ESCUTCHEON (4) flush against finished wall to cover wall opening.
- With VALVE in off position align CROSS HANDLE (5) as shown or as desired. Install CROSS HANDLE (5) onto VALVE STEM (2) and tighten HANDLE SCREW (6). Thread INDEX (7) into CROSS HANDLE (5).



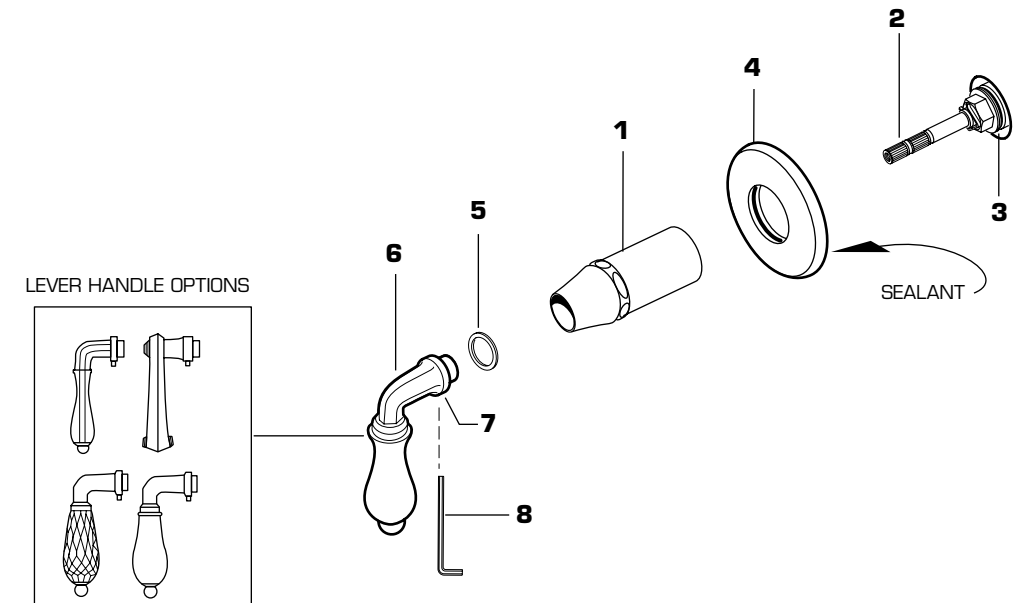

INSTALL LEVER HANDLE

CAUTION

Turn off hot and cold water supplies before beginning.

- Apply sealant to groove on back side of ESCUTCHEON (4). Slide ESCUTCHEON (4) onto BARREL SLEEVE (1).
- Install BARREL SLEEVE (1) over VALVE STEM (2) and thread onto VALVE (3) until it seats tight against the internal stop.
- Slide ESCUTCHEON (4) flush against finished wall to cover wall opening.
- **For Lever Handles:** Install FRICTION WASHER (5) onto base of LEVER HANDLE (6). With VALVE in off position align LEVER HANDLE (6) as shown or as desired. Install LEVER HANDLE (6) onto VALVE STEM (2) and tighten SET SCREW (7) with HEX WRENCH (8) supplied.

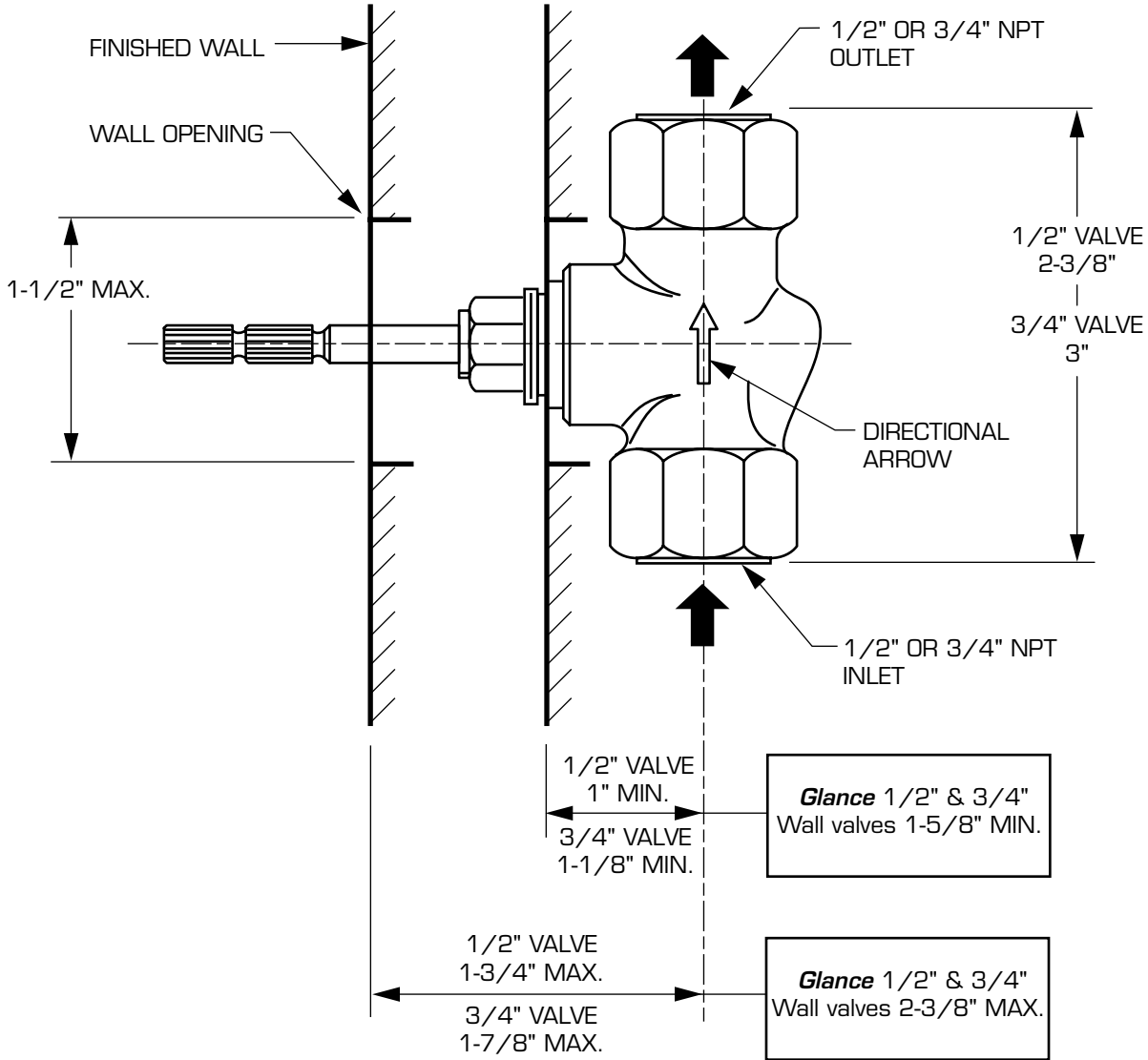

INSTALL ROUGH VALVE

CAUTION Turn off hot and cold water supplies before beginning.

- Determine where the finished wall location will be. This measurement is very important! **NOTE: Rough wall to center of the supply inlet is the same for all series (except Glance) as noted above, leaving a 3/4" tolerance. For the Glance valves (1/2" & 3/4") the rough wall to center of the supply inlet is: 1-5/8" minimum to 2-3/8" maximum, leaving a 3/4" tolerance.**
- Please note the directional arrow on the valve body. This is the direction the water must flow. Make sure the inlet and outlet sides are piped correctly! Do not solder the pipe adapters to wall valve. Use pipe adapters with proper pipe joint compound.
- When installation is complete, turn water supply on and check for proper operation and for leaks prior to the installation of the finished wall.
